FUL-001/26	<b>Election of the Chairman of the Council.</b> Councillors to vote on the appointment of a Chairman of the Council for the municipal year to May 2027. The Chairman is responsible for presiding over meetings of the Council, ensuring the lawful and orderly conduct of business, and acting as the civic representative of the Council. The role carries no additional executive authority outside powers specifically delegated by Council resolution. Declaration of Acceptance of Office to be signed by the appointed Chair.
FUL-002/26	<b>Election of the Vice Chairman of the Council.</b> Councillors to vote on the appointment of a Vice Chairman of the Council for the municipal year to May 2027. The Vice Chairman supports the Chairman and acts in the Chairman's absence in accordance with the Council's Standing Orders. The role does not carry separate executive powers unless specifically delegated by the Council.

- FUL-004/26**      **Apologies for Absence.**  
Councillors to note apologies received.
- FUL-005/26**      **Declarations of Interest.**  
Councillors are required to declare an interest they have in the subsequent agenda items as follows:

     c) Non-registerable interests.  
 Councillors are reminded of their obligation to declare any interests relating to items on this agenda, including where the matter under consideration may affect their property, financial position, or close associations.
- FUL-006/26**      **Co-option to Fill Casual Vacancy on Trowell Parish Council.**

The Chair reserves the right to curtail any contribution which is considered inappropriate or disruptive.

**FUL-012/26**      **Review of Committee and Working Group Structure for 2026/2027.**  
 Councillors to review the Council's committee and working group structure in light of current membership levels and operational requirements, and to determine which committees and working groups should continue during the 2026/2027 municipal year. Committees and individual councillors may only exercise powers formally delegated by the Council.  
 Consideration to include:

     e) Events Committee – to consider whether sufficient membership exists for the committee to continue operating during the 2026/2027 municipal year.
